ADVISEMENT OF RIGHTS

- To appear in court for formal arraignment, plea, and sentencing;
- To have a court trial and challenge the charges;
- To have a speedy court trial and have the charges dismissed if a speedy trial is requested but not provided;
- To be represented by an attorney at your expense;
- To subpoena or present witnesses and physical evidence using the power of the court at no cost to you and to testify on your behalf;
- To confront and cross-examine all witnesses testifying against you under oath; and
- To remain silent and not testify.
